Under the old Penal Code and the original version of the Revised Penal Code, there is no provision that prescribed a single penalty for arson where death resulted. Since there is no legislative prescription of a single penalty for arson with a resulting death, the Supreme Court in U.S. vs. Burns, G. R. No. 16648, March 05, 1921 convicted the accused of a complex crime of arson with homicide under Article 89 of the Old Penal Code (now Article 48 of the Revised Penal Code.
